

## **AMENDMENT REQUEST FORM**

### Who should use this form?

Individuals who previously filed their taxes with Prepare + Prosper (P+P) and now need to file an amended tax return (Form 1040X, M1X, or M1PRX).

You should file an amended return if you need to correct an original return to:

- Report additional income
- Claim additional credits or deductions (including adding dependents or Renter's credit)
- Remove credits or deductions (including removing dependents)
- Change your filing status
- Respond to a letter from the IRS or Minnesota Revenue

### How do I request an amendment?

Fill out the information on the back of this form and include copies of supporting documents for the corrections. Please call 651-262-2167 with any questions.

### How is an amendment processed?

Prepare + Prosper staff or volunteers will prepare your amendment. Please allow 3-4 weeks for staff to process returns or to contact you with follow-up questions. Requests made during the regular tax season (January-April 15) generally take longer due to the high volume of requests.

After your amendment is prepared, P+P staff will contact you about the results and any required next steps. Depending on the type of amendment and year of the return, you may need to sign paperwork and mail in the paperwork to the IRS or MN Department of Revenue to finish filing your amendment.

After your amendment is filed with the IRS or MN Department of Revenue processing can take up to 16 weeks or more.

### What's next?

Additional refunds may be received by direct deposit into your bank account or by a paper check mailed to your address.

If you have a balance due, you can include a check or money order when mailing in your amended return. You can also make payments online or by mail after filing the amended return. P+P staff can provide additional information about paying a balance due or setting up a payment plan with the IRS or Minnesota Revenue.

**Add a dependent.** Include a copy of the dependent's social security card, ITIN letter, or a copy of a previous tax return with the dependent's name and social security number.
